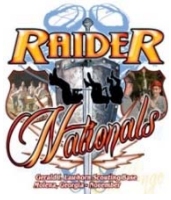

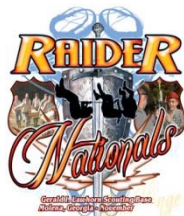

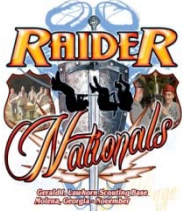

- Failure to Bring All Equipment Across the Finish Line (1-minutes per piece of equipment)
- # Occurrences of Cursing / Unsportsmanlike Conduct (1-minute each)
- Pre-tied knots, blights or marks in the rope to gain advantage (1-minute)
- No Bowline or Figure 8 Farside (1-minute)
- Rope not snapped in OR CORRECTLY over the shoulder (1-minute)
- Failure to use proper Transport Knot (1-minute) - (Wireman OR Figure 8 Slip Knot ONLY!!)
- Hooking up before Nearside Knot is complete (1 minute)
- Incorrect Anchor Knot (Far Side) (1-minute) - (Round Turn 2 half hitches / Tension Anchor (min. 4 wraps) ONLY!!)
- Breaking down bridge before last man off rope (1-minute)
- More than THREE CADETS snapped into the rope at any one time (1-minute PER OCCURANCE)
- Knots/Snaplink still in rope after "time" called (1-minute PER OCCURANCE)
- Dead Zone Violation (1-minute per incident)
- Team False Start (30 seconds)

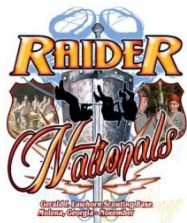

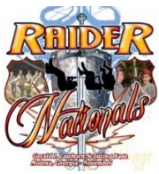

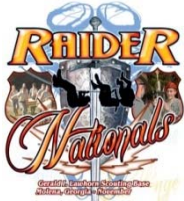
